The Multi-Level design features an insulated base with spill containment sump. As standard, High-Performance Ovens are designed and manufactured to meet the requirements of NFPA 86, Class B ovens. This model is not suitable for applications involving the off-gassing of flammable volatiles, or for installation in electrically hazardous locations. 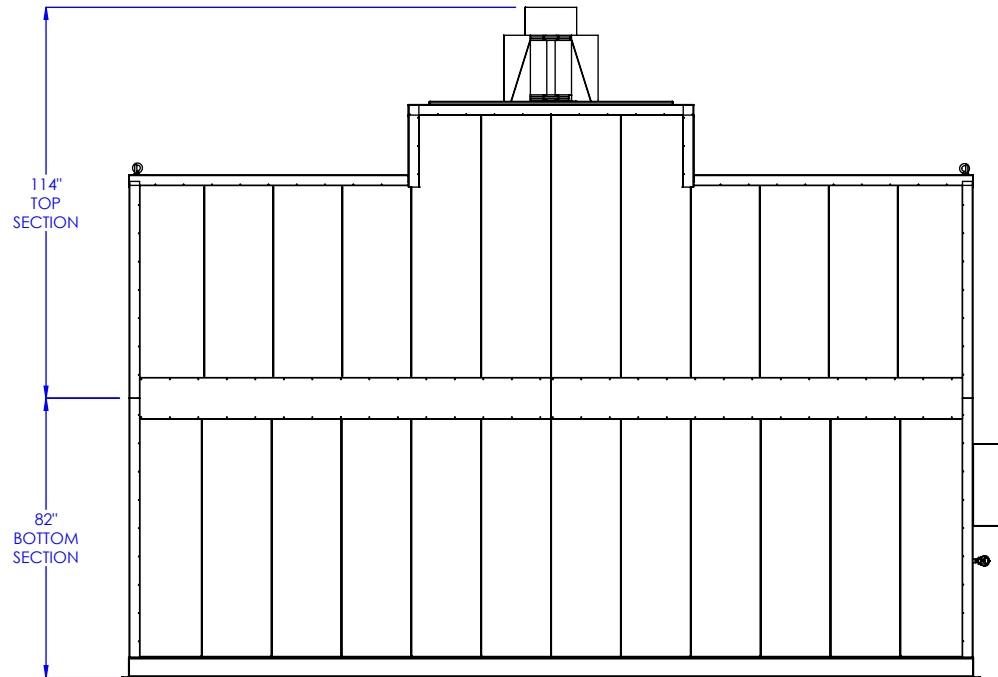
